Cadi is the "go to" person on her cases as team members know and trust her - as do the children. In addition to her work as a CASA volunteer, Cadi has impacted children in the classroom as a teacher.

Since moving into administrative leadership, he continues to serve in various roles and various boards that impact many children in our community.
