CASAs for Kids Fund was created to support the Court Appointed Special Advocate (CASA) program in its efforts to enrich the lives of abused and neglected children in Tippecanoe County. CASA provides an invaluable service speaking up for our most vulnerable children. But sometimes kids need more than a voice – sometimes they need goods or services that are outside the budget of the Department of Child Services.

The Court Appointed Special Advocate (CASA) is a trained community volunteer who speaks for the best interests of abused and neglected children in court. The Tippecanoe County CASA program was started in 1985 and now has more than 100 active volunteers who currently work with more than 400 children in our community.

**Subaru CASA Cycling Challenge**: **24 hours on the test track** is an event to raise funds to support the abused and neglected children of Tippecanoe County. The cycling challenge allows individuals and teams to test their endurance over a 24-hour period while raising funds for children in need. It will be held rain or shine beginning at 10 am Aug. 7 and concluding at 10 am Aug. 8. Electronic lap-counting and timing services will be provided. The event is hosted by Subaru of Indiana Automotive, Inc. at its 2-mile test track in Lafayette.
